

roadworks.org Roadworks API Service Addendum

1 Agreement Integration

This Service Addendum provides for the licensing of the Service known as roadworks.org Roadworks API described in the Service Specification at the URL address http://www.elgin.org.uk/url-terms/roadworks-api-specification (which service description is by this reference hereby incorporated into and forms part of the Agreement).

Capitalised terms used but not defined in this Service Addendum shall have the meaning ascribed to them in the Master Agreement.

2 Customer Restrictions

- 2.1 Unless Elgin specifically agrees in advance and in writing, the Customer shall not:
 - a use, distribute, sublicense or sell any Content including any Roadworks Data outside of the Customer Implementation or incorporate or embed the Service into any of the Customer's products or services that it sells to, or for which it charges, third parties;
 - b attempt to reverse engineer the Service or any component or attempt to create a substitute or similar service through use of or access to the Service;
 - c use the Service in a manner that gives access to mass downloads or bulk feeds of any Content including the Roadworks Data; or
 - d use the Service outside the United Kingdom.

3 Customer Obligations

- 3.1 Compliance. Customer agrees to comply with the terms of the Open Government Licence available at http://www.nationalarchives.gov.uk/doc/open-government-licence/
- 3.2 Attribution Statement. The Customer will ensure that any product or service, and any promotion of any product or service, incorporating any Content including the Roadworks Data carries the following acknowledgement and attribution statement and that any use of any such Content is in accordance with the applicable third party licensor's terms and conditions referenced below which terms and conditions are by this reference herby incorporated into the Agreement:

- 3.3 Customer warrants that the Roadworks Data will not be used in any way that causes detriment to Elgin or brings Elgin into disrepute.



4 Definitions

"Roadworks Data" means roadworks and streetworks information abstracted from Electronic Transfer of Notices (EToN) and other sources of roadworks, streetworks and traffic obstructions pertaining to UK highways.

"Service" means the Elgin Service known as roadworks.org Roadworks API including any bespoke service extensions set out in the applicable Order Form and the associated technical support services provided to the Customer as described in the Service Level Agreement.
